**Hospitality House of Charlotte (HHOC) exists to improve patient outcomes and provide access to care in a safe and caring community environment by hosting patients and family members who are in Charlotte for medical treatments. Most guests at HHOC are receiving treatment for cancer, organ transplantation, cardiac issues, or have a child in the NICU. We lodge guests without regard to age or geographic location, and demand for our services grows along with the renown of Charlotte's world-class medical care. Our 20-bedroom facility, which sleeps up to 56 individuals nightly, offers housing to patients and caregivers (most from rural NC and SC counties), ensuring access to treatment unavailable where they live. We are full with a waitlist most nights.**
